Community Communications from the Board and or residents

Community Documents (Bylaws & Codes, Covenants and Restrictions aka CC&R's)

It is very important that all prospective buyers and current property owners read and understand the CC&R's. The CC&R's are basically the "do's and don'ts" in Northwoods. They may impact plans you have for your new home so contact the Board if you have any questions.

Community assessments & pool dues

HOA assessments are currently \$99, paid twice per year. The biannual assessments apply to all property owners. Pool assessments/dues are \$270 per season. Not all properties are subject to mandatory pool dues. If you are unsure whether your home is a mandatory or non-mandatory property, please confirm with the Board. Pool membership is available to all property owners so non-mandatory property owners are invited to join.

Home Owners Association Board

The community has an active group of 5 members. They are assisted by a management company. Our management company is William Douglas Management. Board member elections are held every year and all property owners are invited to run for a Board position.

Community events

The Board budgets for community events allowing residents to be involved in the HOA community, socialize and have some fun. Community Yard Sales (Spring & Fall), Fall Fest and "Santa comes to Northwoods" are open to all residents of Northwoods. Pool events are open to pool members only.
